

Agenda item 1: Welcome and Introduction

The meeting commenced with a warm welcome to all the members by the IQAC Coordinator, Mr. P. S. Langde, who also briefed the members on the purpose of the meeting and highlighted the importance of continuous quality improvement in academic and administrative processes.

Agenda item 2: Confirmation of the Minutes of the Previous IQAC Meeting

The minutes of the previous IQAC meeting were read and reviewed by the members. After due discussion, the minutes were confirmed unanimously without any modifications.

Agenda item 3: Review of Academic Planning for the Academic Year 2024–25

The committee reviewed the academic calendar, teaching–learning plans, and assessment strategies for the academic year 2024–25. Emphasis was laid on Outcome-Based Education (OBE), effective course delivery, and continuous internal evaluation.

Departments were instructed to prepare and submit detailed academic plans, lesson plans in alignment with university norms and NAAC guidelines.

Agenda item 4: Post-NAAC Quality Sustenance Measures

Dr. A. C. Bhagali briefed the members on the importance of sustaining and enhancing quality standards after **NAAC A Grade accreditation**. The committee discussed strengthening documentation, periodic internal audits, best practices, & continuous improvement mechanisms across all criteria.

It was resolved to monitor quality indicators through regular IQAC meetings and criteria-wise reviews.

Agenda item 5: Discussion on Application for Autonomous Status

The committee discussed in detail the application submitted for grant of Autonomous Status. Dr. Soumya Hublikar informed the members that the application has been duly processed by the concerned authority and that the institute is likely to be conferred with autonomous status soon. The members deliberated on the academic and administrative preparedness required for autonomy. Discussions focused on strengthening academic flexibility, curriculum design, continuous evaluation systems, examination reforms, and effective governance mechanisms. The importance of aligning all academic processes with UGC guidelines and best practices of autonomous institutions was emphasized.

The committee resolved to proactively prepare for autonomy by strengthening academic governance, introducing curriculum enrichment, revising assessment methods, and sensitizing faculty members and staff about autonomous regulations and responsibilities.

Agenda item 6: Planning of Faculty Development Programs, Workshops, Seminars

The committee discussed the planning and organization of Faculty Development Programs (FDPs), workshops, and seminars during the academic year to enhance teaching quality, research capability, and professional competence of faculty members. It was proposed to organize programs on Outcome-Based Education (OBE), NEP 2020, research methodology, innovation and entrepreneurship, pedagogical reforms, and emerging technologies such as AI, Industry 4.0, and data analytics. The committee emphasized the need for practical, hands-on, and interdisciplinary programs.

It was resolved that each department will conduct at least one FDP or workshop.

Agenda item 7: Review of Student-Centric Activities and Support Systems

The committee reviewed student mentoring, career guidance, internship support, co-curricular and extra-curricular activities. Emphasis was laid on holistic student development, employability enhancement, and student well-being.
